DISCLOSURE OF TERMS FOR WIRE TRANSFERS:

The following information pertains to wire transfers conducted with School Systems Federal Credit Union:

- Wire transfer requests received by 2:30pm for domestic wires and 11:30am for international wires, Monday through Friday, will be processed the same day. Transfer requests made after 2:30pm for domestic wires and after 11:30am for international wires on these days will be processed the next business day. Requests made after 2:30pm on Friday and requests made on Saturday will be processed on Monday (with the exception of Holidays) or the next business day. For purposes of this disclosure business days are considered Monday - Friday. Holidays are not considered business days.
- The receiving financial institution may rely on the routing and transit number, even if it identifies a bank different from the named bank.
- The current dividend rate will be paid to the member on the account from which the funds transfer should have occurred or to which the funds transfer was deposited.
- The funds transfer and any applicable fees will be contained in the regular periodic statement from your Credit Union. There will not be a separate receipt provided unless requested by the member.
- Where the beneficiary is identified by name and account number, payments may be made on the basis of only an account number even if the number wrongly identifies someone other than the named beneficiary.
